

Grouptyre/Dunlop Promotion June 2010 Terms and Conditions

1. The promotional period is 1st June 2010 – 30th June 2010 inclusive.
2. This trade incentive promotion is open to trade customers of Group Tyre (UK) Ltd a company registered in England under number 03203659 and whose registered office is at Suite 1 Weaver House Ashville Point, Sutton, Weaver, Runcorn, Cheshire, WA7 3FW (“Grouptyre”) (or a Grouptyre member company) aged 18 years and over (*excluding anyone who is an employee of the Promoter, their immediate families, agents or anyone professionally connected with the promotion*). However, customers trading with Grouptyre (or a Grouptyre member company) as part of a national agreement or contract may not be eligible to participate, dependant on the customer’s Head Office policy. Customers that are not eligible due to their Head Office policy will be informed of such on registration.
3. To participate in the promotion eligible dealers must go to the Grouptyre website www.grouptyre.co.uk/dunlop, answer correctly the question relating to the promotion, and then register for entry into the promotion.
4. All Dunlop car or 4 x 4 tyres with a S, T, H or V speed rating purchased by registered dealers from a member of Grouptyre during the promotional period will count as one entry into the draw. All Dunlop car or 4x4 tyres with a W, Y or Z speed rating purchased by registered dealers from a member of Grouptyre during the promotional period will count as two entries into the draw.
